Reclamation and Paving of Flagg Hill Road, Pine Hill Road and Stonehedge Place**

The Chief Procurement Officer of the Town of Boxborough is soliciting sealed bids for the Reclamation and Paving of Flagg Hill Road, Pine Hill Road and Stonehedge Place.

Bid specifications may be obtained from the Public Safety Dispatch Department, Boxborough Police Station, 520 Massachusetts Ave. Boxborough from 9:00 am – 4:00 pm, Monday through Friday commencing Thursday March 26, 2015, or online at <http://www.boxborough-ma.gov/>. All bids, accompanied by a 5% bid bond or deposit, must be returned to the Chief Procurement Officer, Boxborough Town Hall, 29 Middle Road, Boxborough MA 01719 in a sealed envelope clearly marked “Sealed Bid – Flagg Hill Road, Pine Hill Road and Stonehedge Place” no later than 10:00 a.m. Friday April 10, 2015, at which time bids will be publicly opened and read. The Town will not accept late bids due to any type of mail or courier delay. All bids shall have the name of the bidder clearly marked on the outside of the bid envelope.

All bidders must attend a pre-bid site meeting with the Town’s Engineer, to be held on Tuesday March 31, 2015 at 9:00am. Meeting site shall be at the cul-de-sac on Stonehedge Place, located off Pine Hill Rd. Project maps are included with the IFB.

This contract is subject to the schedule of prevailing wage rates as determined by the Department of Labor and Industries as specified in MGL c149, §§26-27F inclusive. Additionally, bidders must be prequalified by the Massachusetts Department of Transportation or have been granted a waiver by the Prequalification Committee. The minority employee percentage rate to be applied to this project will not be less than 5%.

This contract contains monthly price adjustments for Hot Mix Asphalt Mixtures, Diesel Fuel and Gasoline, and Portland Cement. These adjustments will be determined according to the methods prescribed in Special Provision Documents 00811, 00812 and 00814 of the Commonwealth of Massachusetts.

The Town of Boxborough (Town) reserves the right to reject any or all bids that it deems are not in the best interest of the Town, amend the specifications after giving notice to all known bidders or cancel the procurement.

**1. GENERAL INFORMATION AND BID SUBMISSION REQUIREMENTS**

Pursuant to MGL Chapter 30, sec. 39M, the Town of Boxborough through its Chief Procurement Officer is soliciting Sealed Bids for Reclamation and Paving of Flagg Hill Road, Pine Hill Road and Stonehedge Place and labor associated thereto. The estimated cost of the project is \$584,000.00

**Bid Submission.** All bids shall be accompanied by a 5% bid bond or deposit, and shall be returned to the Chief Procurement Officer, Boxborough Town Hall, 29 Middle Road, Boxborough, MA 01719 in a sealed envelope clearly marked “Sealed Bid – Flagg Hill Road, Pine Hill Road, Stonehedge Place,” no later than 10:00 a.m. Friday April 10, 2015 at which time bids will be publicly opened and read. The Town will not accept late bids on account of mail delays.

All bids shall have the name of the bidder clearly marked on the outside of the bid envelope. Bids, submitted in duplicate, shall be accompanied by “*Certifications Required by Law for Public Construction Contracts*” which is comprised of the required individual certificates, which shall be signed by a duly authorized officer of the bidder’s company, on the form which has been included in the bid packet.

Bids shall be signed as follows: 1) if the bidder is an individual, by her/him personally; 2) if the bidder is a partnership, by the name of the partnership, followed by the signature of each general partner; and 3) if the bidder is a corporation, by the authorized officer, whose signature must be attested to by the Clerk/Secretary of the corporation and the corporate seal affixed. Signatures from salesmen, or representatives of the company other than an authorized officer of the company, are unacceptable and will be grounds for the immediate rejection of the bid. Subject to the requirements of Chapter 29 Section 8B of General Laws, each prospective bidder must be prequalified at the time of the bid opening by the Massachusetts Department of Transportation or have been granted a waiver by the prequalification committee.

**Pre-bid Site Visit.** All bidders must attend a pre-bid site meeting with the Town’s Engineer, to be held on Tuesday March 31, 2015 at 9:00am. Meeting site shall be at the cul-de-sac on Stonehedge Place, located off Pine Hill RD. Project maps are included at the end of this packet.

**Downloading of bid documents.** Bidders downloading information from the Town’s website are solely responsible for obtaining any addenda prior to the bid opening. If Bidder notifies Selina Shaw, Town Administrator by e-mail to [sshaw@boxborough-ma.gov](mailto:sshaw@boxborough-ma.gov) (preferred), by phone to 978-264-1712, or by

fax to 978-264-3127, the bidder will be placed on the bidder's list and will be informed of any changes or items of clarification to this bid. Bidder shall provide the Town Administrator with the name of the company, street address, city, state, zip, phone fax and e-mail address.

**Forms.** Bidder shall use the Town of Boxborough Bid Forms, Letterhead, or plain paper only. Quotation forms listing any other terms & conditions different than specified herein shall not be accepted by the Town.

**Addenda.** If it becomes necessary to revise any part of the Invitation for Bid, or otherwise provide additional information, addenda will be mailed or faxed to all bidders on record as having picked up the IFB.

**Questions.** Requests for approved equal status, clarification of specifications and protests of specifications must be made in writing to the DPW Director at the address listed above and resolved prior to bid opening. Questions may be delivered, e-mailed ([tgarmon@boxborough-ma.gov](mailto:tgarmon@boxborough-ma.gov)), or faxed (978-264-1794) and must be received no later than April 3, 2015. Written responses will be e-mailed or faxed to all bidders on record as having picked up the IFB.

**Bid Modifications.** Bidder may correct, modify, or withdraw a bid by written notice received by the Chief Procurement Officer at the aforementioned address, prior to the time and date set for the bid opening. Bid modifications shall be submitted in a sealed envelope clearly labeled "Modification No. \_\_\_." Each modification must be numbered in sequence, and must reference the original IFB.

After the bid opening, a bidder shall not change any provision of the bid in a manner prejudicial to the interests of the Town or fair competition. Minor informalities will be waived or the bidder will be allowed to correct them. If a mistake and the intended bid are clearly evident on the face of the bid document, the mistake will be corrected to reflect the intended correct bid, and the bidder will be notified in writing; the bidder shall not withdraw the bid. A bidder may withdraw a bid if a mistake is clearly evident on the face of the bid document, but the intended correct bid is not similarly evident.

**Unexpected Closures.** If, at the time of the scheduled bid opening, Town Hall is closed due to uncontrolled events such as fire, weather-related, or building evacuation, the bid opening will be postponed until 10:00 a.m. on the next normal business day. Bids will be accepted until that date and time.

**Right to Cancel or Reject.** The Town of Boxborough reserves the right to cancel this IFB or reject in whole or in part any and all Bids if the Town determines that cancellation or rejection serves the best interests of the Town. If it becomes necessary to revise any part of the IFB, or otherwise provide additional information, addenda will be mailed or faxed to all bidders on record as having picked up the IFB.

## **2. PURCHASE DESCRIPTION**

The Town of Boxborough is receiving sealed Bids for the reclamation and paving of Flagg Hill Road, Pine Hill Road and Stonehedge Place as indicated on the accompanying bid forms. Work on the project must be completed no later than July 31, 2015.

### **2.1 Contract Terms**

All bids may be held by the Town for review, for a period of 30 days. In making a bid the Contractor agrees and acknowledges the 30 day timeline and agrees to hold all prices and timelines as part of the bid for this time period, subject to the provisions of section 2.3, below. The Contractor proposes and agrees to execute an agreement in accordance with the terms of this proposal within ten (10) business days after the mailing to him of notice that the proposal has been accepted and that the aforesaid agreement is ready for signature.

The contractor shall have ten (10) days from the date of notification of contract award to obtain a bid and material payment bond aggregating to 50% of the contract price. Simultaneously with the delivery of the executed contract, the successful bidder shall also be required to post a performance bond in an amount acceptable to the Town as security for the faithful performance of this contract. The form of the Performance and Payment Bond(s) is provided in the bid packet.

The Contract shall be for a one-year period. Parties to the Contract shall be the Chief Procurement Officer for the Town and the authorized agent of the Contractor. The Contractor shall provide liability and other coverage as listed later in this IFB. The Contract may be terminated by the Town if the Contractor refuses to comply with the terms & conditions of the Bid Specifications or Contract. The Town prohibits any activity which would constitute a violation of the conflict of interest statute (MGL c. 268A). The Town prohibits the assignment of any interest in the Contract.

Successful bidders shall provide the Town with sufficient proof that they are able to perform in a timely manner and that they are sufficiently able to supply the labor & materials.

### **2.2 Prevailing Wage**

All work performed under this contract is subject to the schedule of prevailing wage rates as determined by the Department of Labor and Industries as specified in MGL c149, §§26-27F inclusive. The minority employee percentage rate to be applied to this project will not be less than 5%.

The Contractor shall keep payroll records for three years. In addition, the Department of Labor requires all contractors to file weekly payroll records with the awarding authority for all employees working on the project. The Contractor shall file a statement of compliance with the Department of Labor within 15 days of the completion of each project under this contract.

Project Board: The Contractor shall be responsible for erecting and maintaining a project board upon which prevailing wages and other required employer/employee notifications are required. Such a board shall not be posted at the project site, but shall be located where employees of the Contractor shall have rights of access and information.

### **2.3 Pricing**

This contract shall be subject to monthly price adjustments for Hot Mix Asphalt Mixtures, Diesel Fuel and Gasoline and Portland Cement. These adjustments will be determined in accordance with the methods prescribed in Document 00811, Special Provisions Monthly Price Adjustment for Hot Mix Asphalt Mixtures, Feb. 2, 2009, Commonwealth of Massachusetts, Massachusetts Highway Department, and Document 00812, Special Provisions Monthly Price Adjustment for Diesel Fuel and Gasoline, Jan.26, 2009, Commonwealth of Massachusetts, Massachusetts Highway Department; and Document 00814 Special Provisions Price Adjustments for Portland Cement Concrete Mixes, January 12, 2009 Commonwealth of Massachusetts, Massachusetts Highway Department Copies are included for reference.

### **2.4 Quality Requirements**

The term "Specifications" shall mean the Commonwealth of Massachusetts, Department of Public Works "Standard Specifications for Highways and Bridges" 1988 edition and the Supplemental Specification dated June 15, 2012, (referencing Section 460-Class I Bituminous Concrete Type II), as amended. These standards are further detailed with these supplemental specifications. Unless otherwise depicted, shown or specified, the Specifications listed shall be the basis for all submittals, work and payment for work provided for under this Contract.

In the event that any of the materials delivered hereunder fail to conform strictly to the standard specifications of the Department of Public Works, the Town may, at its election, at any time thereafter, terminate its contract without waiving any of its rights and remedies against the Contractor. The Contractor shall be liable to the Town for reimbursement for any amount which the Town may be required to pay to another person or organization for such materials during the remainder of the period covered by the contract, over and above the amount that would have been paid to the Contractor during the balance of said term.

Bidders shall comply with all Bid Submission requirements listed in Section 1 as well as Section 8. Work Items.

### **2.5 Delivery**

During the project, the Contractor shall provide continuous radio communication between the supplying asphalt batch plant and the project to ensure immediate response due to breakdowns, emergencies such as accidents, and to insure the best quality products possible. All plants shall be within a twenty five-mile radius of the Town.

## **3. REFERENCES**

Bidders shall submit on the attached reference forms the names of all municipalities, including contact names, phone and fax numbers, and addresses, for whom the bidder has supplied similar materials or performed similar services within the past five years.

#### **4. RULE FOR AWARD**

The Contract will be awarded to the responsible and eligible bidder offering the lowest total price bid to complete the scope of work in the IFB.

At the bid opening, the total dollar amount of each bid will be read, and the three apparent lowest bids will be selected for further consideration. These three apparent low bids will be read aloud for the benefit of the other bidders and the bid opening procedure will be closed. All those present at the bid opening may examine all bids after the bid opening and after the reading of the three apparent low bids.

Bids will be compared on the basis of the quantities and unit and lump sum prices stated in the bid forms. In the event that there is a discrepancy between the prices written in word and figures, the price written in words will govern.

No award will be made to any bidder who cannot satisfy the Town that he has sufficient ability and experience in this class of work and sufficient capital and plant to enable him to prosecute and complete the work successfully within the time stated. The Town may make such investigations as it deems necessary, and the bidder shall furnish to the Town, under oath if so required, all such information and data for this purpose as the Town may request. The Town's decision or judgment on these matters will be final, conclusive and binding.

Bid securities will be returned to all except the three lowest responsible and eligible bidders within five days, Saturdays, Sundays and legal holidays excluded, after the opening of bids, and the remaining checks will be returned promptly after the Town and the accepted bidder have executed the Contract, or upon demand of the bidder if no notice of intent to award has been presented to the selected contractor within 30 days, Saturdays, Sundays and legal holidays excluded, after the opening of bids.

Notice of award of contract to the successful bidder will be made in writing and delivered by certified mail. Simultaneously with the delivery of the executed contract, the Contractor shall furnish a Performance Bond in an amount not less than one hundred percent (100%) of the Contract for the faithful performance of the Contract and also a Payment Bond in an amount not less than fifty percent (50%) of the Contract as security for the payment of all persons performing labor on the project under this Contract and furnishing materials in connection with this Contract. The Performance Bond and Payment Bond may be in one or in separate instruments in accordance with local law, and shall remain in effect through the one-year period. The form of the Performance and Payment Bond(s) are included with this bid document. Payment and Performance Bonds shall only be issued by a Surety company qualified to do business under the laws of the Commonwealth of Massachusetts.

A Pre-Construction Conference will be held at a date following the awarding of the Contract. The Town Engineer, DPW Director, DPW Foreman will be present at this meeting. The purpose of the meeting is for all parties to be informed of the Contractor's schedule and to provide an opportunity for all parties to discuss the project schedule and any concerns.

## **5. ADDITIONAL TERMS AND CONDITIONS**

### **5.1 Equal Employment Opportunity**

The contractor shall comply with all applicable Equal Employment opportunity laws and regulations.

### **5.2 Ineligible Contractors**

The contractor shall certify that the company is not on the Commonwealth of Massachusetts Comptroller's General List of Ineligible Contractors or has been otherwise dis-barred from Public Work construction in Massachusetts.

### **5.3 Insurance and Indemnification**

Wherever the Contract shall require the application of any of the aforesaid materials in place, the Contractor shall provide liability and other coverage as required by law and shall meet the minimum requirements as specified:

A commercial general liability insurance policy with the following limits of coverage: Bodily injury and property damage, One Million Dollars (\$1,000,000) each occurrence, One Million Dollars (\$1,000,000) each individual claim per occurrence, Three Million Dollars (\$3,000,000) annual aggregate of all claims per occurrence, to include Products/Completed Operations Liability. The MUNICIPALITY shall be named as Additional Insured.

A comprehensive automobile insurance policy with a combined single limit, bodily injury and property damage of at least of One Million Dollars (\$1,000,000) to include Liability coverage for all owned, non-owned and hired vehicles. The MUNICIPALITY shall be named as Additional Insured.

An Umbrella or Excess Liability coverage in the amount of at least Two Million Dollars (\$2,000,000) per occurrence, Two Million Dollars (\$2,000,000) aggregate. The MUNICIPALITY shall be named as Additional Insured.

Workers' Compensation Insurance as required by the then current laws of the Commonwealth of Massachusetts and Employer's Liability Insurance with limits of One Million Dollars (\$1,000,000) /One Million Dollars (\$1,000,000) / One Million Dollars (\$1,000,000).

The Contractor shall be solely responsible for any and all actions of his subcontractor(s) and will be responsible for all material and equipment furnished during execution of the contract and until such time as it is completed to the satisfaction of the Town. Certificates of insurance shall be provided to the Town prior to the award of the contract.

## **5.4 Pre-Construction**

**5.4.1 Pre-disturbance Photographs:** The Contractor shall take photographs of the pre-construction condition of the entire work area, as defined hereinafter. The photographs shall depict the condition of existing driveways, points of connection to other roadways, and other site areas to be altered during the construction process. A copy of the photographs shall be provided to the Town of Boxborough for record purposes.

**5.4.2 Pre-Construction meeting:** If required by Permit or Regulation the Contractor shall hold a pre-construction meeting with any regulatory agency or board entitled to one as part of the base scope of services. The Contractor shall provide sufficient personnel to address scheduling and to discuss the proposed work in relation to issued permits, if any. This meeting may be combined with the pre-construction meeting identified in section 4, above, at the Town's option only.

## **6. SCOPE OF WORK**

### **6.1 General**

**6.1.1** In general, the scope of work includes the reclamation and paving of the entire length of Flagg Hill Road, Pine Hill Road and Stonehedge Place. The work entails full depth roadway reclamation, compaction, horizontal and vertical roadway realignment; furnishing and installing bituminous asphalt; furnishing and installing bituminous berm adjustment of existing drainage structures to finished grade; providing traffic management and other incidental work.

**6.1.2 Work Area:** The scope of work includes all land and areas depicted to be altered on the project plans. The Work Area includes all incidental areas needed to be altered or modified to blend grading or for other purposes as described herein.

**6.2** The estimated quantities shown in the bid forms are approximate and are given to provide a uniform basis for comparison of bids. The Contractor shall calculate and provide all quantities as are necessary to fulfill the scope of work herein-described.

**6.3** The Contractor shall furnish all labor, services, materials, equipment, plant, machinery, apparatus, appliances, tools, supplies, police details and all other incidentals necessary to do all work required for the completion of each item of the work and as herein specified. The workday shall be from 7:00am-4:00pm Monday through Friday. The Town will be responsible for notifying the residents of the scheduled work dates. The Town will place the required Erosion control prior to the commencement of work, and remove after work is completed.

**6.4** The contractor shall, by submitting a bid, confirm that he/she has visited the site to become familiar with the site, its environs and the anticipated scope of work. The Contractor may conduct his/her own site investigations at his/her own costs to confirm and or validate the quantities shown on the bid forms and to ascertain that the scope of work is accurately represented. Queries regarding the above shall be made prior to the submittal of the bid, pursuant to section 1 of this IFB.

## **7. CONTROL OF WORK**

**7.1** The Contractor shall be solely responsible for the control of the work. The Contractor shall be responsible for providing, and ensuring that all subcontractors comply with all bid specifications as outlined in Sec. 7 Control of Work, and Sec. 8 Work Items.

**7.2** A foreman of sufficient experience shall be on-site at all times work of the scope of this contract is being performed. The foreman shall be empowered to stop or change the scope of work, if required to do so for cause by the Town. The Contractor shall assign a Project Manager, who shall be available to the Town during normal business hours to address contract, permit and scheduling items.

**7.3** Traffic Control: As noted in Item 8.9, the Contractor shall include in the base bid the provision of police details for the duration of the work. The Contractor shall also be responsible for all temporary signs, cones, traffic warning devices and steel plates, as determined by the Chief of Police. No work shall be conducted without sufficient markings and signage indicating construction areas, lane closures and other safety measures as determined by the DPW Director or his designee. Temporary signs shall be pre-manufactured or professionally made, clearly worded on a white or orange background with black lettering. Spray painted signs are not acceptable.

**7.4** Drain structure frames, grates and covers shall be firmly cemented in place when adjusted per Specifications. Bituminous patch around drain structures, and gas gates shall be a minimum thickness equivalent to the binder course thickness.

**7.5** The finished graded sub-base shall be tested for smoothness and accuracy of grade and if any portion is found to lack required smoothness and accuracy, such portion shall be re-scarified, reshaped, compacted, and otherwise manipulated until the required smoothness and accuracy are obtained. Road crown shall be 3/8" per foot from center to berm, or 3% cross slope, as indicated in the Specifications. The Contractor is responsible for all finish grades and is also responsible for ensuring the proper drainage of all reconstructed areas.

**7.6** Prior to the installation of the binder course of pavement, the Engineer and the Contractor's representative shall "paint" the edge of pavement and/or the center line to ensure straight uniform road edges and smooth curves and transitions between straight sections. The width of pavement shall be uniform as indicated in the Specifications.

**7.7** Subsequent to the installation of the binder course of pavement, all drain structures, gas gates, and other castings shall be raised to top course grade, and bituminous berm constructed. A uniform and continuous tack coat will be applied and immediately afterward, the top course of bituminous hot mix asphalt shall then be placed.

**7.8** Existing driveways shall be "cut back" and replaced as necessary to ensure a smooth transition onto the grade of new pavement and to ensure runoff water from the street gutter does not enter onto private property or runoff water from private property becomes trapped. No feathering of HMA over existing pavement shall be allowed. A 1-inch lip shall be provided along the gutter at all depressed driveways as indicated in the Specifications. The extent of the proposed limit of cut back shall be painted in the field

for review and approval by the DPW Director or his designee. All joints shall have tack coat and sand applied to assure water does not enter the joint.

**7.9** The longitudinal joint in the pavement shall be a notched edge joint with tack coat applied on the joint prior to the second pass and shall be at the centerline of the roadway.

**7.10** The Contractor shall clean up, at least daily, all refuse, rubbish scrap and surplus material, debris and unneeded construction equipment resulting from the construction operations and sweep the area. The site of the work and the adjacent areas affected thereby shall at all times present a neat, orderly and workmanlike appearance. If in the opinion of the DPW Director or his designee, the referenced areas are not satisfactorily cleaned up, the DPW Director or his designee reserves the right to stop all other work on the project until the cleanup is satisfactory.

**7.11** Where material or debris has washed or flowed into or has been placed in existing watercourses, ditches, gutters, drains, pipes, structures, such material or debris shall be entirely removed and satisfactorily disposed of during progress of the work, and the ditches, gutters, drains, pipes, structures, and work shall, upon completion of the work, be left in a clean and neat condition.

## **8. WORK ITEMS**

### **8.1 Reclamation/ Grade and Compact**

This work item shall consist of grinding existing asphalt to a minimal depth of twice the thickness of pavement and mixing/blending old asphalt pavement with existing sub-base to produce a stabilized aggregate base course free of materials greater than 4" diameter. It is the intention of this work item to produce an improved and stable base layer with existing in-place materials and to perform the work on a timely basis. In the event that the grinding operation causes the blended base material to be removed to reach the proposed grades, the blended material shall be graded to the side or removed and stock piled. The unblended sub-grade material shall be removed to desired depths and the desired blended material shall be replaced on the roadway, compacted and graded to the desired line and grade. Once the grinding process has begun, continuous work shall take place until the completion of the grinding/blending. Equipment designated to do grinding/blending shall be in good repair and ready to perform work.

The reclamation process shall include in the cost of rough grading and compaction of the roadbed material at the unit price. Rough grade shall be defined as a condition that leaves the roadbed accessible by car and free of hazards such as, but not limited to, boulders, stones, potholes and debris (free draining, dust treated and erosion controlled). The existing bituminous pavement shall be pulverized with a self-propelled combination pulverizing and compacting machine, weighing in excess of ten (10) tons, to a depth of twice the existing pavement but not to exceed twelve (12) inches. Equipment such as road planers or cold milling machines, ripping or pushing machines, such as motor graders or bulldozers that are not capable of producing a uniform blend, will not be acceptable for work under this item.

Reclaimed material shall be graded to the lines and grades as directed by the DPW Director or his designee. The roadbed shall be shaped to the Town's standard, graded and compacted to a dense consolidated mass by rolling with a roller not weighing less than 10 tons. At least 1 vibratory roller shall be used on each reclaimed surface and shall have a compaction width of not less than 5 feet. The finished surface shall be tested for smoothness and accuracy of grade, and if any portions are found to

lack the required smoothness, compaction or accuracy, such portions shall be re-shaped, re-compacted and otherwise manipulated as the DPW Director or his designee may direct. The finished surface shall be such that it will not vary more than ¼” from the 10’ straight edge applied to the surface parallel to or at a right angle to the center line.

## **8.2 Calcium Chloride- Dust Control**

At the end of each day’s progress, the Contractor shall apply Calcium Chloride in accordance with the Commonwealth of Massachusetts Standards. Water for roadway dust control shall be applied as directed and is available at the Fire Station. A grader, roller and water wagon shall be maintained on the project site during the reclamation process.

## **8.3 Structures Adjusted to Grade**

This work item is provided to adjust structures to finish grade after the acceptance of the fine graded base. The work will consist of mortaring and repairing the catch basin and manhole tops so that they may not be moved by the flow of traffic during and after construction is complete and aggregate materials do not erode into the basin. The existing grates and covers shall be reused on all basins and manholes, unless they are found to be damaged or non-useable, in such cases the Town shall supply replacement grates, covers and manholes.

## **8.4 Driveway Transitions**

Existing driveways shall be “cut back” and replaced as necessary to ensure a smooth transition onto the grade of new pavement and to ensure runoff water from the street gutter does not enter onto private property or runoff water from private property becomes trapped. No feathering of HMA over existing pavement shall be allowed. A 1-inch lip shall be provided along the gutter at all depressed driveways as indicated in the Specifications. The extent of the proposed limit of cut back shall be painted in the field for review and approval by the DPW Director or his designee. All joints shall have tack coat and sand applied to assure water does not enter the joint.

## **8.5 Binder Course**

Contractor shall furnish and place a ½” aggregate Mass binder course of bituminous concrete at a compacted depth of two inches (2”) total depth and compacted to a dense consolidated mass by rolling with a roller not weighing less than 10 tons. At least 1 vibratory roller shall be used on each reclaimed surface and shall have a compaction width of not less than 5 feet. The finished surface shall be tested for smoothness and pitch, grade and compaction. Surfaces not meeting standards shall be re-compacted or added to if the mix is hot enough or shall be removed and re-applied at no additional cost to the Town.

## **8.6 Berm**

This work item provides the furnishing and placement of bituminous berm. The berm shall be 4” modified Cape Cod. As noted in Item 8.7, a tack coat shall be applied prior to the placement of the berm. Top or wearing course for Cape Cod Berm paving for shall be “HMA Dense Mix” having maximum aggregate size passing 1/2 in. sieve, and bitumen content = 7.4-7.6% ± 1/2% by weight. The Town will provide all backfill and seeding after completion of project.

### **8.7 Tack**

A tack coat of RS-1 or equivalent shall be applied immediately prior to placement of the new surface. Tack shall be applied in a thin uniform coat at an application rate of 0.025 gallons per square yard. The existing surface shall be clean and dry, free of all foreign matter and material prior to application of tack coat. At all edges and transitions of pavement a two (2) inch wide application of tack coat shall be applied.

### **8.8 Top Course**

The Top course shall be compacted to a 2" depth. Top or wearing course paving for shall be "HMA Surface Standard Top Course" having maximum aggregate size passing 5/8 in. sieve, and bitumen content = 5.9%± 1/2% by weight.

### **8.9 Traffic**

A police detail shall be present each day of the project. When deemed necessary by the Chief of Police, a second detail shall be present. The Contractor must make sure the site is useable and safe for the traveling public during work and after work hours. The Contractor shall include in his base bid price the costs necessary for the estimated amount of required police details as indicated on the bid form.

### **8.10 Completion, Close-out:**

The Contract shall not be considered complete and the project not be considered "Closed" regardless of the work effort put forth, unless it meets the following:

1. All construction as required has been fully completed in a professional, workmanlike manner and in a manner meeting the above referenced standards.
2. All un-used products from the Work shall be removed from the Work Area and disposed of as required by law, regulation or contract.
3. No surplus earthen or asphaltic materials shall be left within the Work Area.
4. All earth disturbed by the construction shall be restored to its previous location and condition or, if altered to the design condition specified.
5. No earth shall be left un-stabilized; it shall have permanent paved surface or stabilized lawn or landscape surface.
6. All drainage protective devices and erosion controls shall be removed. All drainage structures shall be cleaned of accumulated sediment prior to any application for final payment.
7. All permitting conditions shall be fully met and documents closing any outstanding permits shall be provided to the Town.





hereinafter called the CONTRACTOR, and the Town of Boxborough, acting by its Town  
Administrator, on behalf of the Board of Selectmen, with a usual place of business at 29 Middle  
Road, Boxborough, MA 01719, hereinafter called the OWNER.

The CONTRACTOR and the OWNER, for the consideration hereinafter named, agree as follows:

1. Scope of Work

The Contractor shall furnish all labor, materials, equipment and insurance to perform all work required for the project known as the *Reclamation and Paving of Flagg Hill Road, Pine Hill Road and Stonehedge Place* Project, in strict accordance with the Contract Documents and all related Drawings and Specifications. The said Documents, Specifications, Drawings and any GENERAL SUPPLEMENTARY CONDITIONS are incorporated herein by reference and are made a part of this Agreement.

2. Contract Price

The Owner shall pay the Contractor for the performance of this Agreement, subject to additions and deductions provided herein, in current funds, the sum of

3. Commencement and Completion of Work and Liquidated Damages

It is agreed that time is of the essence of this Agreement. The Contractor shall commence and prosecute the work under this Agreement upon execution hereof and shall complete the work on or before July 31, 2015.

- A. Definition of Term: The Term "Substantial completion" shall mean the date certified by the Owner when construction is sufficiently complete, in accordance with the Contract Documents, so the Owner may occupy the project, or designated portion(s) thereof, for the use for which it is intended.

- B. Time as Essential Condition: It is understood and agreed that the commencement of and substantial completion of the work are essential conditions of this Agreement. It is further agreed that time is of the essence for each and every portion of the Contract Documents wherein a definite and certain length of time is fixed for the performance of any act whatsoever; and where under the Contract Documents any additional time is allowed for the completion of any work, the new time fixed by such extension shall be of the essence of this Agreement. It is understood and agreed that the times for the completion of the work are reasonable, taking into consideration the average climatic range and usual industrial conditions prevailing in this locality.
- C. Progress and Completion: Contractor shall commence work promptly upon execution of this Agreement and shall prosecute and complete the work regularly, diligently and uninterruptedly at such a rate of progress as will insure Substantial Completion within the stipulated number of calendar days.
- D. Liquidated Damages: It is expressly agreed between the Contractor and the Owner that the Contractor will be responsible for all damages which may arise due to the Contractor's failure to substantially complete the work within the above specified time. If the Contractor shall neglect, fail or refuse to complete the work within the specified number of days, or any extension thereof authorized by the Owner, Contractor agrees, as a part of the consideration for the execution of this Contract by the Owner, to pay the Owner the amount specified herein, not as a penalty, but as liquidated damages for such breach of contract as hereinafter set forth, for each and every calendar day, excluding Saturdays, Sundays and legal Holidays, that the Contractor shall be in default of Substantial completion after the date specified in the Agreement. Due to the impracticability and extreme difficulty of fixing and ascertaining the actual damages the Owner would in such event sustain, said amount is agreed to be the amount of damages which the Owner would sustain, and said amount shall be retained from time to time by the Owner from current periodic estimates. The amount of liquidated damages shall be \$1,000 per day.

4. Performance of the Work

- A. Direction of the Work: The Contractor shall supervise and direct the Work, using his best skills and attention which shall not be less than such state of skill and attention generally rendered by the contracting profession for projects similar to the Project in scope, difficulty and location. The Contractor shall maintain adequate supervisory personnel at the project site during the performance of the Work. He shall be solely responsible for all construction means, methods, techniques, sequences and procedures and for coordinating all portions of the Work under the Agreement.
- B. Responsibility for the Work:
  - (1) The Contractor shall be responsible to the Owner for the acts and omissions of his employees, Subcontractors and their agents and employees, and other persons performing any of the Work under a contract with the Contractor. This obligation

shall also extend to the presence on the Site of suppliers of materials or equipment, their employees, contractors, and agents engaged in the work.

- (2) The Contractor shall not be relieved from his obligations to perform the Work in accordance with the Contract Documents either by the activities or duties of the Owner in its administration of the Agreement, or by inspections, tests or approvals required or performed by persons other than the Contractor.
- C. Permits and Fees: Unless otherwise expressly provided, the Contractor shall secure and pay for all permits and fees, licenses and inspections necessary for the proper execution and completion of the Work which are customarily secured after execution of the Agreement and which are legally required at the time the bids are received, and the same shall at all times be the property of the Owner and shall be delivered to the Owner upon completion of the Project.
- D. Notices, Compliance with Laws:
- (1) The Contractor shall give all notices and comply with all federal, state and local laws, ordinances, rules, regulations and lawful orders of any public authority bearing on the performance of the Work. The Contractor shall provide the Owner with reproductions of all permits, licenses and receipts for any fees paid. The Owner represents that it has disclosed to the Contractor all orders and requirements known to the Owner of any public authority particular to this Agreement.
  - (2) If the Contractor observes that any of the Contract Documents are at variance with applicable laws, statutes, codes and regulations in any respect, he shall promptly notify the Owner in writing, and any necessary changes shall be accomplished by appropriate modification.
  - (3) If the Contractor performs any Work which he knows or should know is contrary to such laws, ordinances, rules and regulations, and without such notice to the Owner, he shall assume full responsibility therefor and shall bear all costs attributable thereto.
  - (4) In the performance of the Work, the Contractor shall comply with all applicable federal, state and local laws and regulations including those relating to workplace and employee safety. The Contractor shall notify the Owner immediately of any conditions at the place of the work which violate said laws and regulations and shall take prompt action to correct and eliminate any such violations.
- E. Project Superintendent: The Contractor shall employ a competent superintendent and necessary assistants who shall be in attendance at the Project site at all times during the progress of the Work. The superintendent shall represent the Contractor and all communications given to the superintendent shall be as binding as if given to the Contractor. Important communications shall be confirmed in writing. Other communications shall be so confirmed on written request in each case.

- F. Progress Schedule: The Contractor, immediately after being awarded the Contract, shall prepare and submit for the Owner's information an estimated progress schedule for the Work. The progress schedule shall be related to the entire Project to the extent required by the Contract Documents, and shall provide for expeditious and practicable execution of the Work.
- G. Drawings, Specifications and Submittals:
- (1) The Contractor shall maintain at the site for the Owner one record copy of all Drawings, Specifications, Addenda, Change Orders and other Modifications, and "As-Built" Drawings and Specifications in good order and marked currently to record all changes made during construction, and approved Shop Drawings, Product Data and Samples. These shall be delivered to the Owner upon completion of the Work.
  - (2) By approving and submitting Shop Drawings, Product Data and Samples, the Contractor represents that he has determined and verified all materials, field measurements, and field construction criteria related thereto, or will do so, and that he has checked and coordinated the information contained within such submittals with the requirements of the Work and of the Contract Documents.
  - (3) The Contractor shall not be relieved of responsibility for any deviation from the requirements of the Contract Documents by the Owner's approval of Shop Drawings, Product Data or Samples unless the Contractor has specifically informed the Owner in writing of such deviation at the time of submission and the Owner has given written approval to the specific deviation. The Contractor shall not be relieved from responsibility for errors or omissions in the Shop Drawings, Product Data or Samples by the Owner's approval thereof.
  - (4) The Contractor shall direct specific attention, in writing or on resubmitted Shop Drawings, Product Data or Samples, to revisions other than those requested by the Owner on previous submittals.
  - (5) No portion of the Work requiring submission of a Shop Drawing, Product Data or Sample shall be commenced until the submittal has been approved by the Owner. All such portions of the Work shall be in accordance with approved submittals.
- H. Protection of the Work and Owner's Property: The Contractor shall at all times safely guard the Owner's property from injury or loss in connection with this Agreement. He shall at all times safely guard and protect his own work, and that of adjacent property from damage. The Contractor shall replace or make good any such damage, loss or injury. The Contractor shall clean the work area and restore it to its original condition upon completion of the work.
- I. Quality of the Work: The Contractor shall perform the work in a good, workmanlike manner. The Contractor hereby guarantees that the entire work constructed by him

under the Agreement will meet fully all requirements thereof as to quality of workmanship and materials. The Contractor hereby agrees to make at his own expense any repairs or replacements made necessary by defects in materials or workmanship supplied to him that become evident within one (1) year after the date of the final payment, and to restore to full compliance with the requirements set forth herein any part of the work constructed hereunder, which during said one (1) year period is found to be deficient with respect to any provisions of the Contract Documents. The Contractor also agrees to hold the Owner harmless from claims of any kind arising from damage due to said defects. The Contractor shall make all repairs and replacements promptly upon receipt of written orders for same from the Owner. If the Contractor fails to make the repairs and replacements promptly, the Owner may do the work and the Contractor shall be liable to the Owner for the cost thereof.

- J. Warranty: The Contractor guarantees to Owner that all materials incorporated into the work will be new unless otherwise specified or agreed. Prior to final payment, the Contractor shall deliver to the Owner all manufacturers' warranties, together with such endorsements or assignments as are necessary to ensure to the Owner the full rights and benefits of such warranties.

5. Affirmative Action/Equal Employment Opportunity

The Contractor is directed to comply with all applicable State Laws, Ordinances, Bylaws, and rules and regulations regarding affirmative action/equal employment opportunity requirements. Failure of the Contractor to comply with any such law, rule or regulation shall constitute grounds for the Owner to terminate the Agreement.

6. Site Information Not Guaranteed; Contractor's Investigation

All information given in the Contract Documents relating to subsurface and other conditions, natural phenomena, existing pipes, and other structures is from the best sources at present available to the Owner. All such information is furnished only for the information and convenience of the Contractor and is not guaranteed.

It is agreed and understood that the Owner does not warrant or guarantee that the subsurface or other conditions, natural phenomena, existing pipes, or other structures encountered during construction will be the same as those indicated in the Contract Documents.

Contractor has familiarized himself with the nature and extent of the Contract Documents, work, locality, and with all local conditions and federal, state, and local laws, rules, ordinances, and regulations that in any manner may affect costs, progress, or performance of the work. Contractor has made, or has caused to be made, examinations, investigations, and tests and studies of such reports and related data in addition to those referred to in the paragraph above as he deems necessary for the performance of the work at the Contract Price, within the Contract Time, and in accordance with the other Terms and Conditions of the Contract Documents; and no additional examinations, tests, investigations, reports, and similar data are or will be required by the Contractor for such purposes.

Contractor has correlated the results of all such observations, examinations, investigations, tests, reports, and data with the Contract Documents. Contractor has given the Owner written notice of all conflicts, errors, or discrepancies that he has discovered in the Contract Documents, and the resolution thereof by the Owner is acceptable to the Contractor.

It is further agreed and understood that the Contractor shall not use or be entitled to use any of the information made available to him or obtained in any examination made by him in any manner as a basis of or ground for any claim or demand against the Owner, arising from or by reason of any variance which may exist between the information made available and the actual subsurface conditions or other conditions or structures actually encountered during the construction work, except as may otherwise be expressly provided for in the Contract Documents.

7. Project Architect or Engineer

There X is is not a project architect-engineer for this project who is Places Associates, Inc. Except as otherwise indicated in the Contract Documents, the Architect/Engineer shall be a representative of the Owner and the Contractor shall direct all communications, questions and comments on the work and the performance thereof to the Architect/Engineer. Except as otherwise provided, the Architect/Engineer shall have all the authority of the Owner set forth in the Contract Documents. In general, the Architect/Engineer shall have the authority to review the performance of the work, reject work which is defective or otherwise does not comply with the Contract Documents and to order the Contractor to remedy defective work and take such actions which are necessary to make the work conform to the Contract Documents.

8. Wage Rates

Prevailing Wage Rates as determined by the Commissioner of the Department of Labor and Workforce Development under the provisions of Massachusetts General Laws, Chapter 149, Section 26 to 27G, as amended, apply to this project. It is the responsibility of the Contractor to provide the Town with certified payrolls and to comply with all requirements of the above-cited statutes.

The schedules of prevailing wage rates are included in the Contract Documents.

9. Payments to the Contractor

Within fifteen (15) days after receipt from the Contractor of a proper and satisfactory periodic estimate requesting payment of the amount due for the preceding month, the Owner shall have fifteen (15) days to make payment for:

- A. The work performed during the preceding month.
- B. The materials not incorporated in the Work but delivered and suitably stored at the site (or at some location agreed upon in writing) to which the Contractor has title, or

to which a Subcontractor has title and has authorized the Contractor to transfer title to the Owner.

C. Less the following retention items:

- (1) A retention based on an estimate of the fair value of the Owner's claims against the Contractor.
- (2) A retention for direct payments to Subcontractors, if any, based on demands for same in accordance with the provisions of Section 39F of Chapter 30 of the General Laws.
- (3) A retention not exceeding five percent (5%) of the approved amount of the periodic payment.

D. After the receipt of a periodic estimate requesting final payment and within sixty-five (65) days after the Contractor fully completes the Work, or substantially completes the Work so that the value of the Work remaining to be done is, on the estimate of the Owner, less than 1% of the original Contract Price, or substantially completes the Work and the Owner takes possession or occupancy, whichever occurs first, the Owner shall pay the Contractor the entire balance due on the Contract less:

- (1) A retention based on an estimate of the fair value of the Owner's claims against the Contractor and of the cost of completing the incomplete and unsatisfactory items of work.
- (2) A retention for direct payments to Subcontractors, if any, based on demands of same in accordance with the provisions of Section 39F of Chapter 30 of the General Laws, or based on the record of payments by the Contractor to the Subcontractors under this Contract if such record of payment indicates that the Contractor has not paid Subcontractors as provided in Section 39F of Chapter 30 of the General Laws.

If the Owner fails to make payment as herein provided, there shall be added to each such payment, daily interest at the rate of 3 percentage points above the rediscount rate than charged by the Federal Reserve Bank of Boston, commencing on the first day after said payment is due, and continuing until the payment is delivered or mailed to the Contractor; provided that no interest shall be due, in any event, on the amount of a periodic estimate for final payment until fifteen (15) days after receipt of such a periodic estimate by the Owner as provided in the first paragraph of this Article. The Contractor agrees to pay to each subcontractor a portion of any such interest paid in accordance with the amount due each subcontractor.

The Owner may make changes in any periodic estimate submitted by the Contractor and the payment due on said periodic estimate shall be computed in accordance with the changes so made, and such changes and any requirements for a corrected periodic estimate shall not affect the due date for the periodic payment or the date for the

commencement of interest charges on the amount of the periodic payment computed in accordance with the changes made, as provided herein; provided further, that the Owner may, within seven (7) days after receipt, return to the Contractor for correction, any periodic estimate which is not in acceptable form or which contains computations not arithmetically correct, and in that event, the date of receipt of such periodic estimate shall be the date of receipt of the corrected periodic estimate in proper form and with arithmetically correct computations. The date of receipt of a periodic estimate received on a Saturday shall be the first working day thereafter.

E. Changes in the Work: No changes in the work covered by the approved Contract Documents shall be made without prior written approval of the Owner. Charges or credits for the work covered by the approved change shall be determined by one or more, or a combination of the following methods:

(1) Unit bid prices previously approved.

(2) An agreed lump sum.

(3) The actual cost of:

(a) Labor.

(b) Materials entering permanently into the work.

(c) The ownership or rental cost of construction equipment during the time of use on the extra work.

(d) Power and consumable supplies for the operation of power equipment.

(e) Wages to be paid.

To the cost under (3) there shall be added a fixed fee to be agreed upon but not to exceed fifteen percent (15%) of the actual cost of work. The fee shall be compensation to cover the cost of supervision, overhead, bond, profit and any other general expenses.

F. Claims for Additional Costs: If the Contractor wishes to make a claim for an increase in the Contract Sum, he shall give the Owner written notice thereof within twenty days after the occurrence of the event giving rise to such claim. This notice shall be given by the Contractor before proceeding to execute the Work, except in an emergency endangering life or property. No such claim shall be valid unless so made. Any change in the Contract Sum resulting from such claim shall be authorized by Change Order.

The Contractor hereby agrees that the Contractor shall have no claim for damages of any kind against the Town on account of any delay in the commencement or performance of the work and/or any hindrance, delay or suspension of any portion of

the work including, but not limited to, any claims or damages on account of having to perform out of sequence work, claims for damages on account of loss of production or other interference with the work whether such delay is caused by the Town or otherwise, except as and to the extent expressly provided under G.L. c.30, §39O in the case of written orders by the Town. The Contractor acknowledges that the Contractor's sole remedy for any such claim will be an extension of time as provided herein.

10. Final Payment, Effect

The acceptance of final payment by the Contractor shall constitute a waiver of all claims by the Contractor arising under the Agreement.

11. Contract Documents

- Specifications and Addenda
- Contract Drawings
- Schedule of Prevailing Wages  
(Strike out any inapplicable item)

12. Terms Required By Law

This Agreement shall be considered to include all terms required to be included in it by the Massachusetts General Laws, and all other laws, as though such terms were set forth in full herein.

13. Indemnification

The Contractor shall indemnify and hold harmless the Owner from and against any and all claims, damages, losses, and expenses, including attorney's fees, arising out of the performance of this Agreement when such claims, damages, losses, and expenses are caused, in whole or in

part, by the acts, errors, or omissions of the Contractor or his employees, agents, subcontractors or representatives.

#### 14. Insurance

The Contractor shall purchase and maintain such insurance as will protect both the Owner and the Contractor from claims which may arise under the Agreement, including operations performed for the named insured by independent contractors and general inspection thereof by the named insured. In addition, the Contractor shall require its subcontractors to maintain such insurance. Coverage shall be provided for:

- (1) claims under workers' or workmen's compensation, disability benefit and other applicable employee benefit acts;
- (2) claims for damages because of bodily injury, occupational sickness or disease, or death of Contractor's employees;
- (3) claims for damages because of bodily injury, sickness or disease, or death of any person other than Contractor's employees;
- (4) claims for damages insured by usual personal injury liability coverage which are sustained (1) by any person as a result of an offense directly or indirectly related to the employment of such person by the Contractor, or (2) by any other person;
- (5) claims for damages, including damages to the Work itself, because of injury to or destruction of tangible property, including loss of use resulting therefrom; and
- (6) claims for damages because of bodily injury or death of any person or property damage arising out of the ownership, maintenance or use of any motor vehicle.
- (7) claims involving contractual liability applicable to the Contractor's obligations under Article 13.

The limits of liability for coverage required under the preceding paragraph shall be as Specified in the Supplemental Conditions.

Except for Workmen's Compensation, all liability coverage shall name the Town as an additional insured and shall provide for 30 days prior written notice to the Town of any modification or termination of coverage provided thereby. The Contractor shall provide the Owner with appropriate certificate(s) of insurance evidencing compliance with this provision prior to the commencement of any work under this Agreement.

#### 15. Notice

All notices required to be given hereunder shall be in writing and delivered to, or mailed first class to, the parties' respective addresses stated above. In the event that immediate notice is

required, it may be given by telephone or facsimile, but shall, to the extent possible, be followed by notice in writing in the manner set forth above.

16. Termination

- A. Each party shall have the right to terminate this Agreement in the event of a failure of the other party to comply with the terms of the Agreement. Such termination shall be effective upon seven days' notice to the party in default and the failure within that time of said party to cure its default.
- B. The Owner shall have the right to terminate the Agreement without cause, upon ten (10) days' written notice to the Contractor. In the event that the Agreement is terminated pursuant to this subparagraph, the Contractor shall be reimbursed in accordance with the Contract Documents for all Work performed up to the termination date, and for all materials or equipment not incorporated in the Work, but delivered and suitably stored at the site. Payment for material or equipment stored at the site shall be conditioned upon submission by the Contractor of bills of sale or such other evidence as is satisfactory to Owner to establish the Owner's title to such material or equipment or otherwise protect the Owner's interests.

17. Miscellaneous

- A. **Royalties and Patents:** The Contractor shall pay all royalties and license fees. He shall defend all suits or claims for infringement of any patent rights and shall save the Owner harmless from loss on account thereof, except that the Owner shall be responsible for all such loss when a particular design, process or the product of a particular manufacturer or manufacturers is specified; but if the Contractor believes or has reason to believe that the design, process or product specified is an infringement of a patent, he shall be responsible for such loss unless he promptly gives such information to the Owner, and thereafter the Owner insists on the use of the design, process or products specified.
- B. **Assignment:** The Contractor shall not assign or transfer any of its rights, duties or obligations under this Agreement without the written approval of the Owner.
- C. **Governing Law:** This Agreement shall be governed by and construed in accordance with the law of the Commonwealth of Massachusetts.
- D. By its signature hereon, the Contractor certifies, under the pains and penalties of perjury, that it has complied with all laws of the Commonwealth of Massachusetts relating to taxes, reporting of employees and contractors, and withholding and remitting child support.

After the Surety's obligation under this Bond arises, the Surety is obligated, to the limit of the amounts of this Bond, for (1) the correction of defective work and completion of the Construction Contract; (2) additional design, professional services, and legal costs, including attorneys' fees, resulting from the Contractor Default or from the default of the Surety under this Bond; (3) any additional work beyond the Construction Contract made necessary by the Contractor Default or default of the Surety under this Bond; (4) indemnification obligation of the Principal, if any, as provided in the Construction Contract; and (5) liquidated damages as provided in the Construction Contract, or if none are so specified, actual and foreseeable consequential damages resulting from the Contractor Default or default of the Surety under this Bond.

Any proceeding, legal or equitable, under this Bond shall be instituted in any court of competent jurisdiction in the Commonwealth of Massachusetts.

The Surety, for value received, hereby stipulates and agrees that no change, extension of time, alteration or addition to the terms of the Construction Contract or to the work to be performed thereunder or the specifications accompanying the same shall in any way affect its obligation on this Bond, and it does hereby waive notice of any such change, extension of time, alteration or addition to the terms of the Construction Contract or to the work or to the specifications.

**§ SC 1.1 INTRODUCTION**

The following provisions modify, change, delete from or add to Agreement. Where any Subsection of the Agreement is modified or any Article Paragraph, Subparagraph or Clause thereof is modified or deleted by these Supplemental Conditions, the unaltered provisions of that Article, Paragraph, Subparagraph or Clause shall remain in effect.

**§ SC 2.1 PREVAILING WAGE**

In accordance with General Laws Chapter 149, Section 26 through 27D, the Contractor is obligated to comply with the prevailing wage rates established by the Commissioner of the Department of Labor and Workforce Development for mechanics, apprentices, chauffeurs, teamsters and laborers employed on the Project. The schedule of applicable prevailing wage rates for the Project, together with a Certificate of Compliance therewith, are set forth in Attachment A herein.

**§ SC 3.1 CONTRACTOR'S LIABILITY INSURANCE**

In no case shall the limits of liability be less than the following:

1. Contractor's Liability Insurance
  - a. Workers' Compensation:

      - \$3,000,000 Aggregate All Claims per Occurrence
    2. Products and Completed Operations
      - \$1,000,000 Each Occurrence (bodily injury and property damage)
      - \$3,000,000 Aggregate All Claims per Occurrence
    3. Property Damage Liability (including coverage for XCU hazards).
      - \$1,000,000 Each Occurrence
      - \$1,000,000 Each Individual Claim per Occurrence
      - \$3,000,000 Aggregate All Claims per Occurrence
    4. Products and Completed Operations insurance shall be maintained for a minimum period of 2 years after final payment and Contractor shall continue to provide evidence of such coverage to Owner on an annual basis during the aforementioned.
