The Chief Procurement Officer of the Town of Boxborough is soliciting sealed bids for the restoration of the Steele Farm Barn exterior.

Bid specifications may be obtained from the Boxborough Police Department, 520 Massachusetts Ave., Boxborough, MA from 8:00 am – 4:00 pm, Monday through Friday commencing July 22, 2015, or online at <http://www.boxborough-ma.gov/>. Those downloading IFB must notify D. Monteiro by email to [dmonteiro@boxborough-ma.gov](mailto:dmonteiro@boxborough-ma.gov) to ensure notification of any addenda.

All bids, accompanied by a 5% bid bond or deposit, must be submitted to the Chief Procurement Officer, Boxborough Town Hall, 29 Middle Road, Boxborough MA 01719 in a sealed envelope clearly marked “Sealed Bid – Restoration of the Steele Farm Barn exterior” no later than August 10, 2015, at which time bids will be publicly opened and read. The Town will not accept late bids due to any type of mail or courier delay. All bids shall have the name of the bidder clearly marked on the outside of the bid envelope.

Although not mandatory, bidders are strongly encouraged to attend a pre-bid site meeting to be held at 10AM July 29, 2015 in the Morse-Hilberg meeting room, Town Hall, 29 Middle Road, Boxborough.

This contract is subject to the schedule of prevailing wage rates as determined by the Department of Labor and Industries as specified in MGL c149, §§26-27F inclusive.

The Town of Boxborough (Town) reserves the right to reject any or all bids that it deems are not in the best interest of the Town, amend the specifications after giving notice to all known bidders or cancel the procurement.

**1. GENERAL INFORMATION AND BID SUBMISSION REQUIREMENTS**

Pursuant to MGL Chapter 30, sec. 39M, the Town of Boxborough through its Chief Procurement Officer is soliciting Sealed Bids for Restoration of the Steele Farm Barn exterior and labor associated thereto. The estimated cost of the project is \$90,000.

**Bid Submission.** All bids shall be accompanied by a 5% bid bond or deposit, and shall be returned to the Chief Procurement Officer, Boxborough Town Hall, 29 Middle Road, Boxborough, MA 01719 in a sealed envelope clearly marked “Sealed Bid – Restoration of the Steele Farm Barn exterior” no later than August 10, 2015 at 10AM at which time bids will be publicly opened and read. The Town will not accept late bids on account of mail delays.

All bids shall have the name of the bidder clearly marked on the outside of the bid envelope. Bids, submitted in duplicate, shall be accompanied by *Certifications Required By law for Public Construction Projects*, which shall be signed by a duly authorized officer of the bidder’s company, on forms which have been included in the bid packet.

Bids shall be signed as follows: 1) if the bidder is an individual, by her/him personally; 2) if the bidder is a partnership, by the name of the partnership, followed by the signature of each general partner; and 3) if the bidder is a corporation, by the authorized officer, whose signature must be attested to by the Clerk/Secretary of the corporation and the corporate seal affixed. Signatures from salesmen, or representatives of the company other than an authorized officer of the company, are unacceptable and will be grounds for the immediate rejection of the bid. Subject to the requirements of Chapter 29 Section 8B of General Laws, each prospective bidder must be prequalified at the time of the bid opening by the Massachusetts Department of Transportation or have been granted a waiver by the prequalification committee.

**Pre-bid Site Visit.** All bidders may attend a pre-bid site meeting to be held on July 29, 2015 at 10AM starting at Town Hall in the Morse/Hilberg Meeting Room, 29 Middle Road, then proceeding to the Steele Farm Barn, 484 Middle Road.

**Downloading of bid documents.** Bidders downloading information from the Town’s website are solely responsible for obtaining any addenda prior to the bid opening. If Bidder notifies Denise Monteiro, Department Assistant by e-mail to [dmonteiro@boxborough-ma.gov](mailto:dmonteiro@boxborough-ma.gov) (preferred), by phone to 978-264-1726, or by fax to 978-264-3127, the bidder will be placed on the bidder’s list

and will be informed of any changes or items of clarification to this bid. Bidder shall provide the Building Department Assistant with the name of the company, street address, city, state, zip, phone fax and e-mail address.

**Forms.** Bidder shall use the Town of Boxborough Bid Forms, Letterhead, or plain paper only. Quotation forms listing any other terms & conditions different than specified herein shall not be accepted by the Town.

**Addenda.** If it becomes necessary to revise any part of the Invitation for Bid, or otherwise provide additional information, addenda will be mailed or faxed to all bidders on record as having picked up the Invitation for Bid.

**Questions.** Requests for approved equal status, clarification of specifications and protests of specifications must be made in writing to the Inspector of Buildings at the address listed above, and resolved prior to bid opening. Questions may be delivered, e-mailed ([dlindberg@boxborough-ma.gov](mailto:dlindberg@boxborough-ma.gov)), or faxed (978-264-3127) and must be received no later than 8/4/2015 at 5PM. Written responses will be e-mailed or faxed to all bidders on record as having picked up the IFB.

**Bid Modifications.** Bidder may correct, modify, or withdraw a bid by written notice received by the Chief Procurement Officer at the aforementioned address, prior to the time and date set for the bid opening. Bid modifications shall be submitted in a sealed envelope clearly labeled "Modification No. \_\_\_." Each modification must be numbered in sequence, and must reference the original IFB.

After the bid opening, a bidder shall not change any provision of the bid in a manner prejudicial to the interests of the Town or fair competition. Minor informalities will be waived or the bidder will be allowed to correct them. If a mistake and the intended bid are clearly evident on the face of the bid document, the mistake will be corrected to reflect the intended correct bid, and the bidder will be notified in writing; the bidder shall not withdraw the bid. A bidder may withdraw a bid if a mistake is clearly evident on the face of the bid document, but the intended correct bid is not similarly evident.

**Unexpected Closures.** If, at the time of the scheduled bid opening, Town Hall is closed due to uncontrolled events such as fire, weather-related, or building evacuation, the bid opening will be postponed until 10:00 a.m. on the next normal business day. Bids will be accepted until that date and time.

**Right to Cancel or Reject.** The Town of Boxborough reserves the right to cancel this IFB or reject in whole or in part any and all Bids if the Town determines that cancellation or rejection serves the best interests of the Town. If it becomes necessary to revise any part of the IFB, or otherwise provide additional information, addenda will be mailed or faxed to all bidders on record as having picked up the IFB.

## **2. PURCHASE DESCRIPTION**

The Town of Boxborough is soliciting sealed Bids for the Restoration of the Steele Farm Barn Exterior as indicated on the accompanying bid forms. Work on this project must be completed no later than November 14, 2015.

### **2.1 Contract Terms**

All bids may be held by the Town for review, for a period of 30 days. In making a bid the Contractor agrees and acknowledges the 30 day timeline and agrees to hold all prices and timelines as part of the bid for this time period, subject to the provisions of section 2.3, below. The Contractor proposes and agrees to execute an agreement in accordance with the terms of this bid within ten (10) business days after the mailing to him of notice that the bid has been accepted and that the aforesaid agreement is ready for signature.

The Contractor shall have ten (10) days from the date of notification of contract award to obtain a bid and material payment bond aggregating to 50% of the contract price. Simultaneously with the delivery of the executed contract, the successful bidder shall also be required to post a performance bond in an amount no less than 100% of the contract as security for the faithful performance of this contract. The form of the Performance and Payment Bond(s) is included in the form of contract, which has been provided in the bid packet.

The Contract shall be for a one-year period. Parties to the Contract shall be the Chief Procurement Officer for the Town and the authorized agent of the Contractor. The Contractor shall provide liability and other coverage as listed later in this IFB. The Contract may be terminated by the Town if the Contractor refuses to comply with the terms & conditions of the Bid Specifications or Contract. The Town prohibits any activity which would constitute a violation of the conflict of interest statute (MGL c. 268A). The Town prohibits the assignment of any interest in the Contract.

Successful bidders shall provide the Town with sufficient proof that they are able to perform in a timely manner and that they are sufficiently able to supply the labor & materials as specified.

### **2.2 Prevailing Wage**

All work performed under this contract is subject to the schedule of prevailing wage rates as determined by the Department of Labor and Industries as specified in MGL c149, §§26-27F inclusive.

The Contractor shall keep payroll records for three years. In addition, the Department of Labor requires all contractors to file weekly payroll records with the awarding authority for all employees working on the project. The Contractor shall file a statement of compliance with the Department of Labor within 15 days of the completion of each project under this contract.

Project Board: The Contractor shall be responsible for erecting and maintaining a project board on site upon which prevailing wages and other required employer/employee notifications are required.

### **2.3 Quality Requirements**

All work must be performed in accordance with 780CMR; The State Building Code.

In the event that the work performed under this contract fails to conform strictly to the standard specifications of the bid, the Town may, at its election, at any time thereafter, terminate its contract without waiving any of its rights and remedies against the Contractor. The Contractor shall be liable to the Town for reimbursement for any amount that the Town may be required to pay to another person or organization for such materials during the remainder of the period covered by contract, over and above the amount that would have been paid to the contractor during the balance of said term.

Bidders shall comply with all Bid Submission requirements listed in Section 1 as well as Section 6. Work Items.

### **2.4 Onsite Storage of Materials**

The Contractor will have the use of the barn for storage of materials and equipment.

## **3. REFERENCES**

Bidders shall submit on the attached reference forms the names of all customers, including contact names, phone and fax numbers, and addresses, for whom the bidder has supplied performed similar services within the past five years.

## **4. RULE FOR AWARD**

The Contract will be awarded to the responsible and eligible bidder offering the lowest total price bid to complete the scope of work in the IFB.

At the bid opening, the total dollar amount of each bid will be read, and the three apparent lowest bids will be selected for further consideration. These three apparent low bids will be read aloud for the benefit of the other bidders and the bid opening procedure will be closed. All those present at the bid opening may examine all bids after the bid opening and after the reading of the three apparent low bids.

No award will be made to any bidder who cannot satisfy the Town that he has sufficient ability and experience in this class of work and sufficient capital and equipment to enable him to prosecute and complete the work successfully within the time stated. The Town may make such investigations as it deems necessary, and the bidder shall furnish to the Town, under oath if so required, all such information and data for this purpose as the Town may request. The Town's decision or judgment on these matters will be final, conclusive and binding.

Bid securities will be returned to all except the three lowest responsible and eligible bidders within five days, Saturdays, Sundays and legal holidays excluded, after the opening of bids, and the remaining checks will be returned promptly after the Town and the accepted bidder have executed the Contract, or upon demand of the bidder if no notice of intent to award has been presented to the selected contractor within 30 days, Saturdays, Sundays and legal holidays excluded, after the opening of bids.

Notice of award of contract to the successful bidder will be made in writing. Simultaneously with the delivery of the executed contract, the Contractor shall furnish a Performance Bond in an amount not less than one hundred percent (100%) of the Contract for the faithful performance of the Contract and also a Payment Bond in an amount not less than fifty percent (50%) of the Contract as security for the payment of all persons performing labor on the project under this Contract and furnishing materials in connection with this Contract. The Performance Bond and Payment Bond may be in one or in separate instruments in accordance with local law, and shall remain in effect through the term of the contract. The form of the Performance and Payment Bond(s) are included in the form of contract, which has been provided with the bid packet. Payment and Performance Bonds shall only be issued by a Surety company qualified to do business under the laws of the Commonwealth of Massachusetts.

## **5. ADDITIONAL TERMS AND CONDITIONS**

### **5.1 Equal Employment Opportunity**

The Contractor shall comply with all applicable Equal Employment Opportunity laws and regulations.

### **5.2 Ineligible Contractors**

The Contractor shall certify that the company is not on the Commonwealth of Massachusetts Comptroller's General List of Ineligible Contractors or has been otherwise dis-barred from Public Work construction in Massachusetts.

### **5.3 Licensure**

The Contractor must possess a valid and current Construction Supervisor License issued by the Commonwealth of Massachusetts.

### **5.4 Insurance and Indemnification**

Wherever the Contract shall require the application of any of the aforesaid materials in place, the Contractor shall provide liability and other coverage as required by law and shall meet the minimum requirements as specified:

A commercial general liability insurance policy with the following limits of coverage: Bodily injury and property damage, One Million Dollars (\$1,000,000) each occurrence, One Million

Dollars (\$1,000,000) each individual claim per occurrence, Three Million Dollars (\$3,000,000) annual aggregate of all claims per occurrence, to include Products/Completed Operations Liability. The MUNICIPALITY shall be named as Additional Insured.

A comprehensive automobile insurance policy with a combined single limit, bodily injury and property damage of at least of One Million Dollars (\$1,000,000) to include Liability coverage for all owned, non-owned and hired vehicles. The MUNICIPALITY shall be named as Additional Insured.

An Umbrella or Excess Liability coverage in the amount of at least Two Million Dollars (\$2,000,000) per occurrence, Two Million Dollars (\$2,000,000) aggregate. The MUNICIPALITY shall be named as Additional Insured.

Workers' Compensation Insurance as required by the then current laws of the Commonwealth of Massachusetts and Employer's Liability Insurance with limits of One Million Dollars (\$1,000,000) /One Million Dollars (\$1,000,000) / One Million Dollars (\$1,000,000).

The Contractor shall be solely responsible for any and all actions of his subcontractor(s) and will be responsible for all material and equipment furnished during execution of the contract and until such time as it is completed to the satisfaction of the Town. Evidence of insurance shall be provided to the Town prior to the award of the contract.

## **5.5 Pre-Construction**

**5.5.1 Building Permit** The Contractor must apply for and receive a building permit from the Boxborough Building Department. The permit fee will be waived.

**5.5.2 Trash Removal** At their own expense, the Contractor must supply an enclosed container for the trash. All construction debris shall be cleaned up at the end of each day. The area around the driveway and parking spaces must remain accessible for use by the residents of Boxborough.

**5.5.3 Portable Toilets** The Contractor must supply a portable toilet for use by his crew. The Contractor shall be responsible for delivery, cleaning and removal of the portable toilet.

## **6. SCOPE OF WORK**

**6.1 General** In general, the scope of work is the restoration of the exterior of the Steele Farm Barn. The work entails removal and replacement of all the wood, siding, trim, windows and doors. Upon completion of the carpentry work the entire building is to be painted as specified below.

**6.2 Carpentry** To be completed as specified in Exhibit 1 and below.

**6.2.1** Replace all windows, sills and casings. Two double hung in gables and 10-32"x30" (overall frame) true divided 6 lite barn sash with 1 1/16"x 3 3/4" composite flat casing and 1 5/8" composite sill by BROSCO or equivalent (approval required).

**6.2.2** Replace large barn doors, door hardware, and cover as per attached drawings and specifications.

**6.2.3** Replace door on northeast side with a flush door as per attached drawings, hung in new BROSCO or equivalent (approval required) framesaver jamb with exterior aluminum threshold, new hasp and thumb latch.

**6.2.4** Replace 48"x7'6" 8 lite sliding door on northwest side with 6 lite flush sliding door similar to large barn doors as per attached drawings.

**6.2.5** Replace manure door on south side with flush door as per attached drawings, hung in new BROSCO or equivalent (approval required) framesaver jamb with exterior aluminum threshold, and hasp and hook and eye on interior side.

**6.2.6** Replace all siding and corner boards and door trim. Use actual measure 7/8" thick solid wood and 1/2"x6" pre-primed red cedar clapboards attached with 2 1/2" stainless steel ring shanked nails into barn framing all installed over Tyvec or equivalent (approval required) after nailing existing board sheathing as needed.

**6.2.7** Repair or replace as necessary upon consultation with Inspector of Buildings, rotted sills on northeast and northwest corners of the barn (specify allowance).

**6.2.8** Solid wood for door casings and corner boards to be approved wood for exterior applications such as cedar, redwood, fir, mahogany, cypress, white oak or approved substitute.

### **6.3 PAINTING**

**6.3.1** Contractors must comply with applicable lead paint regulations.

**6.3.2** All new or raw wood shall be primed with Benjamin Moore Primer (094) or equivalent (approval required).

**6.3.3** Prepare rake and fascia boards for primer and prime with Benjamin Moore Exterior Wood Primer (094) or equivalent (approval required).

**6.3.4** Use Dap Dynaflex 230 white caulking or equivalent (approval required) where necessary.

**6.3.5** Paint complete exterior with 2 coats Benjamin Moore Aura Waterborne Exterior paint or equivalent (approval required).

**6.4** The Contractor shall furnish all labor, services, materials, equipment, plant, machinery, apparatus, appliances, tools, supplies, police details and all other incidentals necessary to do all work required for the completion of each item of the work and as herein specified.

**6.5** The Contractor shall, by submitting a bid, confirm that he/she has visited the site to become familiar with the site, its environs and the anticipated scope of work. The Contractor may conduct his/her own site investigations at his/her own costs to confirm that the scope of work is accurately represented and understood. Queries regarding the above shall be made prior to the submittal of the bid, pursuant to section 1 of this IFB.

## **7. WORKMANSHIP**

The Contractor shall be properly licensed pursuant to the Massachusetts Building Code and shall provide sufficiently qualified workmen and supervisors who shall be present at all times during execution of their part of the work. All workmen shall be thoroughly familiar with the type of project and specified materials and techniques. No allowances shall be made in accepting or rejecting work for lack of proper supervision or workmen's lack of skill.

## **8. COMPLETION, CLOSE-OUT**

**8.1** The Contract shall not be considered complete and the project not be considered "Closed" regardless of the work effort put forth, unless it meets the following:

1. All construction as required has been fully completed in a professional, workmanlike manner and in a manner meeting the above referenced standards.
2. All un-used products from the work shall be removed from the work area and returned for credit to the Town or disposed of as required by law, regulation or contract.
3. All earth disturbed by the construction shall be restored to its previous condition.
4. All permitting conditions shall be fully met and final inspection completed.

**8.2** Punch List: Before release of final payment, a punch list, created by the Inspector of Buildings or his agent, shall be completed by the Contractor and signed off by the Inspector of Buildings or his agent.

## **9. WARRANTY**

Contractor shall provide a written warranty for all materials and labor for a period of three (3) years from the date of completion.






LARGE BARN DOORS TRACK + ROOF





- (2) All employees to be employed at the worksite will have successfully completed a course in construction safety and health approved by the United States Occupational Safety and Health Administration that is at least 10 hours in duration at the time the employee begins work and they shall furnish documentation of successful completion of said course with the first certified payroll report for each employee; and
- (3) All employees to be employed in the work subject to this contract have successfully completed a course in construction safety and health approved by the United States Occupational Safety and Health Administration that is at least 10 hours in duration.



- This wage schedule applies only to the specific project referenced at the top of this page and uniquely identified by the "Wage Request Number" on all pages of this schedule.
- An Awarding Authority must request an updated wage schedule from the Department of Labor Standards ("DLS") if it has not opened bids or selected a contractor within 90 days of the date of issuance of the wage schedule. For CM AT RISK projects (bid pursuant to G.L. c.149A), the earlier of: (a) the execution date of the GMP Amendment, or (b) the bid for the first construction scope of work must be within 90-days of the wage schedule issuance date.
- The wage schedule shall be incorporated in any advertisement or call for bids for the project as required by M.G.L. c. 149, § 27. The wage schedule shall be made a part of the contract awarded for the project. The wage schedule must be posted in a conspicuous place at the work site for the life of the project in accordance with M.G.L. c. 149 § 27. The wages listed on the wage schedule must be paid to employees performing construction work on the project whether they are employed by the prime contractor, a filed sub-bidder, or any sub-contractor.
- All apprentices working on the project are required to be registered with the Massachusetts Division of Apprentices Standards (DAS). Apprentice must keep his/her apprentice identification card on his/her person during all work hours on the project. An apprentice registered with DAS may be paid the lower apprentice wage rate at the applicable step as provided on the prevailing wage schedule. **If an apprentice rate is not listed on the prevailing wage schedule for the trade in which an apprentice is registered with the DAS, the apprentice must be paid the journeyworker's rate for the trade.**
- The wage rates will remain in effect for the duration of the project, except in the case of multi-year public construction projects. For construction projects lasting longer than one year, awarding authorities must request an updated wage schedule. Awarding authorities are required to request these updates no later than two weeks before the anniversary of the date the contract was executed by the awarding authority and the general contractor. For multi-year CM AT RISK projects, awarding authority must request an annual update no later than two weeks before the anniversary date, determined as the earlier of: (a) the execution date of the GMP Amendment, or (b) the execution date of the first amendment to permit procurement of construction services. Contractors are required to obtain the wage schedules from awarding authorities, and to pay no less than these rates to covered workers. The annual update requirement is not applicable to 27F "rental of equipment" contracts.
- Every contractor or subcontractor which performs construction work on the project is required to submit weekly payroll reports and a Statement of Compliance directly to the awarding authority by mail or email and keep them on file for three years. Each weekly payroll report must contain: the employee's name, address, occupational classification, hours worked, and wages paid. Do not submit weekly payroll reports to DLS. A sample of a payroll reporting form may be obtained at <http://www.mass.gov/dols/pw>.
- Contractors with questions about the wage rates or classifications included on the wage schedule have an affirmative obligation to inquire with DLS at (617) 626-6953.
- Employees not receiving the prevailing wage rate set forth on the wage schedule may report the violation to the Fair Labor Division of the office of the Attorney General at (617) 727-3465.
- Failure of a contractor or subcontractor to pay the prevailing wage rates listed on the wage schedule to all employees who perform construction work on the project is a violation of the law and subjects the contractor or subcontractor to civil and criminal penalties.

OWNER-CONTRACTOR AGREEMENT

THIS AGREEMENT made this \_\_\_\_\_ day of \_\_\_\_\_ in the year 2015, between \_\_\_\_\_ with a usual place of business at \_\_\_\_\_, hereinafter called the CONTRACTOR, and the Town of Boxborough, a municipal corporation duly organized and existing under the laws of the Commonwealth of Massachusetts, acting by and through its Town Administrator, on behalf of Board of Selectmen with a usual place of business at 29 Middle Road, Boxborough, MA 01719, hereinafter called the OWNER.

The CONTRACTOR and the OWNER, for the consideration hereinafter named, agree as follows:

**1. Scope of Work**

The Contractor shall furnish all labor, services, materials, equipment, machinery, apparatus, appliances, tools and supplies necessary to perform all work required for the completion of each item of the Work specified in the IFB for the Restoration of the Steele Farm Barn Exterior. The said Documents, Specifications, Drawings and any GENERAL SUPPLEMENTARY CONDITIONS are incorporated herein by reference and are made a part of this Agreement.

**2. Contract Price**

The Owner shall pay the Contractor for the performance of this Agreement, subject to additions and deductions provided herein, in current funds, the sum of \_\_\_\_\_.

**3. Commencement and Completion of Work and Liquidated Damages**

It is agreed that time is of the essence of this Agreement. The Contractor shall commence and prosecute the work under this Agreement upon execution hereof and shall complete the work on or before November 14, 2015, unless mutually agreed to extend. A time extension may be granted due to permitting delays, access to town buildings or other situations not in control of the Contractor.

- A. Definition of Term: The Term "Substantial completion" shall mean the date certified by the Owner when construction is sufficiently complete, in accordance with the Contract Documents, so the Owner may occupy the project, or designated portion(s) thereof, for the use for which it is intended.
- B. Time as Essential Condition: It is understood and agreed that the commencement of and substantial completion of the work are essential conditions of this Agreement. It is further agreed that time is of the essence for each and every portion of the Contract Documents wherein a definite and certain length of time is fixed for the performance of any act whatsoever; and where under the Contract Documents any additional time is allowed for the completion of any work, the new time fixed by such extension shall be of the essence of this Agreement. It is understood and agreed that the times for the completion of the work are reasonable, taking into consideration the average climatic range and usual industrial conditions prevailing in this locality.

- C. Progress and Completion: Contractor shall commence work promptly upon execution of this Agreement and shall prosecute and complete the work regularly, diligently and uninterruptedly at such a rate of progress as will insure Substantial Completion within the stipulated number of calendar days.
- D. Liquidated Damages: It is expressly agreed between the Contractor and the Owner that the Contractor will be responsible for all damages which may arise due to the Contractor's failure to substantially complete the work within the above specified time. If the Contractor shall neglect, fail or refuse to complete the work within the specified number of days, or any extension thereof authorized by the Owner, Contractor agrees, as a part of the consideration for the execution of this Contract by the Owner, to pay the Owner the amount specified herein, not as a penalty, but as liquidated damages for such breach of contract as hereinafter set forth, for each and every calendar day, excluding Saturdays, Sundays and legal Holidays, that the Contractor shall be in default of Substantial completion after the date specified in the Agreement. Due to the impracticability and extreme difficulty of fixing and ascertaining the actual damages the Owner would in such event sustain, said amount is agreed to be the amount of damages which the Owner would sustain, and said amount shall be retained from time to time by the Owner from current periodic estimates. The amount of liquidated damages shall be \$750 per day.

#### **4. Performance of the Work**

- A. Direction of the Work: The Contractor shall supervise and direct the Work, using his best skills and attention which shall not be less than such state of skill and attention generally rendered by the contracting profession for projects similar to the Project in scope, difficulty and location. The Contractor shall maintain adequate supervisory personnel at the project site during the performance of the Work. He shall be solely responsible for all construction means, methods, techniques, sequences and procedures and for coordinating all portions of the Work under the Agreement.
- B. Responsibility for the Work:
  - (1) The Contractor shall be responsible to the Owner for the acts and omissions of his employees, Subcontractors and their agents and employees, and other persons performing any of the Work under a contract with the Contractor. This obligation shall also extend to the presence on the Site of suppliers of materials or equipment, their employees, contractors, and agents engaged in the work.
  - (2) The Contractor shall not be relieved from his obligations to perform the Work in accordance with the Contract Documents either by the activities or duties of the Owner in its administration of the Agreement, or by inspections, tests or approvals required or performed by persons other than the Contractor.
- C. Notices, Compliance with Laws:
  - (1) The Contractor shall give all notices and comply with all federal, state and local laws, ordinances, rules, regulations and lawful orders of any public authority bearing on the performance of the Work. The Contractor shall provide the Owner with reproductions of all permits, licenses and receipts for any fees paid. The Owner represents that it has disclosed to the Contractor all orders and requirements known to the Owner of any public authority particular to this Agreement.
  - (2) If the Contractor observes that any of the Contract Documents are at variance with applicable laws, statutes, codes and regulations in any respect, he shall promptly notify the Owner in writing, and any necessary changes shall be accomplished by appropriate modification.
  - (3) If the Contractor performs any Work which he knows or should know is contrary to such laws, ordinances, rules and regulations, and without such notice to the Owner, he shall assume full responsibility therefore and shall bear all costs attributable thereto.

- (4) In the performance of the Work, the Contractor shall comply with all applicable federal, state and local laws and regulations including those relating to workplace and employee safety. The Contractor shall notify the Owner immediately of any conditions at the place of the work which violate said laws and regulations and shall take prompt action to correct and eliminate any such violations.
  - (5) Conflict of Interest: Contractor agrees that, to the extent that such law is applicable to the duties Contractor is to perform hereunder, Contractor shall comply with the provisions of Chapter 268A of the General Laws concerning conflict of interest and that Contractor presently has no interest and shall not acquire any interest, direct or indirect, which would conflict in any manner or degree with the services required to be performed under this agreement.
- D. Project Superintendent: The Contractor shall employ a competent superintendent and necessary assistants who shall be in attendance at the Project site at all times during the progress of the Work. The superintendent shall represent the Contractor and all communications given to the superintendent shall be as binding as if given to the Contractor. Important communications shall be confirmed in writing. Other communications shall be so confirmed on written request in each case.
- E. Progress Schedule: The Contractor, immediately after being awarded the Contract, shall prepare and submit for the Owner's information an estimated progress schedule for the Work. The progress schedule shall be related to the entire Project to the extent required by the Contract Documents, and shall provide for expeditious and practicable execution of the Work.
- F. Drawings, Specifications and Submittals (as applicable):
- (1) The Contractor shall maintain at the site for the Owner one record copy of all Drawings, Specifications, Addenda, Change Orders and other Modifications, and "As-Built" Drawings and Specifications in good order and marked currently to record all changes made during construction, and approved Shop Drawings, Product Data and Samples. These shall be delivered to the Owner upon completion of the Work.
  - (2) By approving and submitting Shop Drawings, Product Data and Samples, the Contractor represents that he has determined and verified all materials, field measurements, and field construction criteria related thereto, or will do so, and that he has checked and coordinated the information contained within such submittals with the requirements of the Work and of the Contract Documents.
  - (3) The Contractor shall not be relieved of responsibility for any deviation from the requirements of the Contract Documents by the Owner's approval of Shop Drawings, Product Data or Samples unless the Contractor has specifically informed the Owner in writing of such deviation at the time of submission and the Owner has given written approval to the specific deviation. The Contractor shall not be relieved from responsibility for errors or omissions in the Shop Drawings, Product Data or Samples by the Owner's approval thereof.
  - (4) The Contractor shall direct specific attention, in writing or on resubmitted Shop Drawings, Product Data or Samples, to revisions other than those requested by the Owner on previous submittals.
  - (5) No portion of the Work requiring submission of a Shop Drawing, Product Data or Sample shall be commenced until the submittal has been approved by the Owner. All such portions of the Work shall be in accordance with approved submittals.
- G. Protection of the Work and Owner's Property: The Contractor shall at all times safely guard the Owner's property from injury or loss in connection with this Agreement. He shall at all times safely guard and

protect his own work, and that of adjacent property from damage. The Contractor shall replace or make good any such damage, loss or injury. The Contractor shall clean the work area and restore it to its original condition upon completion of the work.

- H. **Quality of the Work:** The Contractor shall perform the work in a good, workmanlike manner. The Contractor hereby guarantees that the entire work constructed by him under the Agreement will meet fully all requirements thereof as to quality of workmanship and materials. The Contractor hereby agrees to make at his own expense any repairs or replacements made necessary by defects in materials or workmanship supplied to him that become evident within three (3) years after the date of final acceptance, and to restore to full compliance with the requirements set forth herein any part of the work constructed hereunder, which during said three (3) year period is found to be deficient with respect to any provisions of the Contract Documents. The Contractor also agrees to hold the Owner harmless from claims of any kind arising from damage due to said defects. The Contractor shall make all repairs and replacements promptly upon receipt of written orders for same from the Owner. If the Contractor fails to make the repairs and replacements promptly, the Owner may do the work and the Contractor shall be liable to the Owner for the cost thereof.
- J. **Warranty:** The Contractor guarantees to Owner that all materials incorporated into the work will be new unless otherwise specified or agreed. Prior to final payment, the Contractor shall deliver to the Owner all manufacturers' warranties, together with such endorsements or assignments as are necessary to ensure to the Owner the full rights and benefits of such warranties.
- K. **Payment and Performance Bonds:** The Contractor shall post a payment bond, in the amount of 50% of the contract price. This payment bond shall be in the form of surety issued by an insurance company licensed by the State Division of Insurance. This payment bond is mandatory on all construction projects for all political subdivisions and ensures payment of all workers and vendors used for the contract.

Simultaneously with the delivery of the executed contract, the Contractor shall also be required to post a performance bond in an amount acceptable to the Owner as security for the faithful performance of this Contract.

## **5. Affirmative Action/Equal Employment Opportunity**

The Contractor is directed to comply with all applicable State Laws, Ordinances, Bylaws, and rules and regulations regarding affirmative action/equal employment opportunity requirements. Failure of the Contractor to comply with any such law, rule or regulation shall constitute grounds for the Owner to terminate the Agreement.

## **6. Site Information Not Guaranteed; Contractor's Investigation**

All information given in the Contract Documents relating to subsurface and other conditions, natural phenomena, existing pipes, and other structures is from the best sources at present available to the Owner. All such information is furnished only for the information and convenience of the Contractor and is not guaranteed. It is agreed and understood that the Owner does not warrant or guarantee that the subsurface or other conditions, natural phenomena, existing pipes, or other structures encountered during construction will be the same as those indicated in the Contract Documents.

Contractor has familiarized himself with the nature and extent of the Contract Documents, work, locality, and with all local conditions and federal, state, and local laws, rules, ordinances, and regulations that in any manner may affect costs, progress, or performance of the work. Contractor has made, or has caused to be made, examinations, investigations, and tests and studies of such reports and related data in addition to those referred to

in the paragraph above as he deems necessary for the performance of the work at the Contract Price, within the Contract Time, and in accordance with the other Terms and Conditions of the Contract Documents; and no additional examinations, tests, investigations, reports, and similar data are or will be required by the Contractor for such purposes.

Contractor has correlated the results of all such observations, examinations, investigations, tests, reports, and data with the Contract Documents. Contractor has given the Owner written notice of all conflicts, errors, or discrepancies that he has discovered in the Contract Documents, and the resolution thereof by the Owner is acceptable to the Contractor.

It is further agreed and understood that the Contractor shall not use or be entitled to use any of the information made available to him or obtained in any examination made by him in any manner as a basis of or ground for any claim or demand against the Owner, arising from or by reason of any variance which may exist between the information made available and the actual subsurface conditions or other conditions or structures actually encountered during the construction work, except as may otherwise be expressly provided for in the Contract Documents.

## **7. Project Architect or Engineer**

Except as otherwise indicated in the Contract Documents, the Architect/Engineer shall be a representative of the Owner and the Contractor shall direct all communications, questions and comments on the work and the performance thereof to the Architect/Engineer. Except as otherwise provided, the Architect/Engineer shall have all the authority of the Owner set forth in the Contract Documents. In general, the Architect/Engineer shall have the authority to review the performance of the work, reject work which is defective or otherwise does not comply with the Contract Documents and to order the Contractor to remedy defective work and take such actions which are necessary to make the work conform to the Contract Documents.

## **8. Wage Rates**

Prevailing Wage Rates as determined by the Commissioner of the Department of Labor and Workforce Development under the provisions of Massachusetts General Laws, Chapter 149, Section 26 to 27G, as amended, apply to this project. It is the responsibility of the Contractor to provide the Town with certified payrolls and to comply with all requirements of the above-cited statutes.

The schedules of prevailing wage rates are included in the Contract Documents.

## **9. Payments to the Contractor**

- A. The Owner will make payment to the Contractor in accordance with the provisions of Sections 39F and 39G of Chapter 30 of the General Laws of the Commonwealth of Massachusetts. The Contractor shall submit requisitions for payment as required by said provisions and the directions of the Owner. The Owner will remit payment within 30 days of receipt of invoice.
- B. The Contractor's applications for payment shall be subject to approval by the Inspector of Buildings.
- C. Changes in the Work: No changes in the work covered by the approved Contract Documents shall be made without prior written approval of the Owner. Charges or credits for the work covered by the approved change shall be determined by one or more, or a combination of the following methods:
  - (a) Unit bid prices previously approved.

- (b) An agreed lump sum.
- (c) The actual cost of:
  - (1) Labor.
  - (2) Materials entering permanently into the work.
  - (3) The ownership or rental cost of construction equipment during the time of use on the extra work.
  - (4) Power and consumable supplies for the operation of power and equipment.
  - (5) Wages to be paid.

To the cost under (c) there shall be added a fixed fee to be agreed upon but not to exceed fifteen percent (15%) of the actual cost of work. The fee shall be compensation to cover the cost of supervision, overhead, bonds, profit and any other general expenses.

- D. Claims for Additional Costs: If the Contractor wishes to make a claim for an increase in the Contract Sum, he shall give the Owner written notice thereof within twenty days after the occurrence of the event giving rise to such claim. This notice shall be given by the Contractor before proceeding to execute the Work, except in an emergency endangering life or property. No such claim shall be valid unless so made. Any change in the Contract Sum resulting from such claim shall be authorized by Change Order.

## **10. Final Payment, Effect**

The acceptance of final payment by the Contractor shall constitute a waiver of all claims by the Contractor arising under the Agreement.

## **12. Terms Required By Law**

This Agreement shall be considered to include all terms required to be included in it by the Massachusetts General Laws, and all other laws, applicable to the work required under this Agreement as though such terms were set forth in full herein.

## **13. Indemnification**

The Contractor shall indemnify and hold harmless the Owner from and against any and all claims, damages, losses, and expenses, including attorney's fees, arising out of the performance of this Agreement when such claims, damages, losses, and expenses are caused, in whole or in part, by the acts, errors, or omissions of the Contractor or his employees, agents, subcontractors or representatives.

## **14. Insurance**

The Contractor shall purchase and maintain such insurance as will protect both the Owner and the Contractor from claims which may arise under the Agreement, including operations performed for the named insured by independent contractors and general inspection thereof by the named insured. In addition, the Contractor shall require its subcontractors to maintain such insurance. Coverage shall be provided for:

1. claims under workers' or workmens' compensation, disability benefit and other applicable employee benefit acts;
2. claims for damages because of bodily injury, occupational sickness or disease, or death of Contractor's employees;
3. claims for damages because of bodily injury, sickness or disease, or death of any person other than Contractor's employees;
4. claims for damages insured by usual personal injury liability coverage which are sustained (1) by any person as a result of an offense directly or indirectly related to the employment of such person by the Contractor, or (2) by any other person;
5. claims for damages, including damages to the Work itself, because of injury to or destruction of tangible property, including loss of use resulting therefrom;
6. claims for damages because of bodily injury or death of any person or property damage arising out of the ownership, maintenance or use of any motor vehicle; and
7. claims involving contractual liability applicable to the Contractor's obligations under Article 13.

The limits of liability for coverage required under the preceding paragraph shall be as required by the Owner.

Except for Workmen's Compensation, all liability coverage shall name the Town of Boxborough as an additional insured and shall provide for 30 days prior written notice to the Town of any modification or termination of coverage provided thereby. The Contractor shall provide the Owner with appropriate certificate(s) of insurance evidencing compliance with this provision prior to the commencement of any work under this Agreement.

## **15. Independent Contractor**

Nothing herein contained shall be construed as creating the relationship of employer and employee or principal and agent between the Town and Contractor. Contractor shall not have any authority to represent, commit or bind the Town to any other person, firm, association or corporation or to submit proposals or make any representation on behalf of the Town without the express prior authorization of the Town Administrator.

## **16. Notice**

All notices required to be given hereunder shall be in writing and delivered to, or mailed first class to, the parties' respective addresses stated above. In the event that immediate notice is required, it may be given by telephone or facsimile, but shall, to the extent possible, be followed by notice in writing in the manner set forth above.

## **17. Termination**

- A. Each party shall have the right to terminate this Agreement in the event of a failure of the other party to comply with the terms of the Agreement. Such termination shall be effective upon seven days' notice to the party in default and the failure within that time of said party to cure its default.
- B. The Owner shall have the right to terminate the Agreement without cause, upon ten (10) days' written notice to the Contractor. In the event that the Agreement is terminated pursuant to this subparagraph, the Contractor shall be reimbursed in accordance with the Contract Documents for all Work performed up to the termination date, and for all materials or equipment not incorporated in the Work, but delivered and suitably stored at the site. Payment for material or equipment stored at the site shall be conditioned upon submission by the Contractor of bills of sale or such other evidence as is satisfactory to Owner to establish the Owner's title to such material or equipment or otherwise protect the Owner's interests.

## **18. Miscellaneous**

- A. Royalties and Patents: The Contractor shall pay all royalties and license fees. He shall defend all suits or claims for infringement of any patent rights and shall save the Owner harmless from loss on account thereof, except that the Owner shall be responsible for all such loss when a particular design, process or the product of a particular manufacturer or manufacturers is specified; but if the Contractor believes or has reason to believe that the design, process or product specified is an infringement of a patent, he shall be responsible for such loss unless he promptly gives such information to the Owner, and thereafter the Owner insists on the use of the design, process or products specified.
- B. Assignment: The Contractor shall not assign or transfer any of its rights, duties or obligations under this Agreement without the written approval of the Owner.
- C. Governing Law: This Agreement shall be governed by and construed in accordance with the law of the Commonwealth of Massachusetts.
- D. Enforceability: In the event any provision of this Agreement is found to be legally unenforceable, such unenforceability shall not prevent the enforcement of any other provision of this Agreement, all of which shall remain in full force and effect as though the unenforceable provision had never appeared herein. No waiver by either the Town or Consultant of a breach hereof or a default hereunder shall be deemed a waiver by such party of a subsequent breach or default of like or similar nature. If, moreover, any one or more of the provisions of this Agreement shall for any reason be held to be excessively broad as to

duration, geographical scope, activity of subject, it shall be construed by limiting or reducing it so as to be enforceable to the extent compatible with applicable law.

- E. By its signature hereon, the Contractor certifies, under the pains and penalties of perjury, that it has complied with all laws of the Commonwealth of Massachusetts relating to taxes, reporting of employees and contractors, and withholding and remitting child support.

### **§ SC 1.1 INTRODUCTION**

The following provisions modify, change, delete from or add to Agreement. Where any Subsection of the Agreement is modified or any Article Paragraph, Subparagraph or Clause thereof is modified or deleted by these Supplemental Conditions, the unaltered provisions of that Article, Paragraph, Subparagraph or Clause shall remain in effect.

### **§ SC 2.1 PREVAILING WAGE**

In accordance with General Laws Chapter 149, Section 26 through 27D, the Contractor is obligated to comply with the prevailing wage rates established by the Commissioner of the Department of Labor and Workforce Development for mechanics, apprentices, chauffeurs, teamsters and laborers employed on the Project. The schedule of applicable prevailing wage rates for the Project, together with a Certificate of Compliance therewith, are set forth in Attachment A herein.

### **§ SC 3.1 CONTRACTOR'S LIABILITY INSURANCE**

In no case shall the limits of liability be less than the following:
