1. Approve minutes of January 9th, 2024

Catie motioned to approve. Andy seconded. All in favor, motion passed.

2. Finance

Christopher presented a summary of the funds available to the Steele Farm Committee (Kangas Trust, Ice House Fund, Farmhouse Phase 3, Revolving Fund). Overall picture is that all funding sources are in good shape and that ongoing projects are financially sound.

The town is drawing up a long-term contract for mowing and haying for all relevant Town properties, including Steele Farm.

Christopher talked to Susan DiLorenzo, who offered to help oversee renovations. David suggested that Michael Johns could also help.

5. Old business

a. Capital Plan

i. Parking Lot Status: Christopher talked to Trustees of Reservations. They are interested in helping—they have provided guidance for similar projects on other properties. Trustees suggested that crushed gravel might be an option but that noted that the project should also include water management. Trustees also suggested talking to Heritage Foundation, who has

experience with similar projects. The committee discussed the need for an engineering scope for the water management aspect of the project. All agreed that it would be inadvisable to stripe individual parking spaces in the parking lot.

b. Handbook

c. Camping Policy

No progress since last meeting. Andy noted that the committee needs to decide first on policy objectives. Christopher and John noted that the camping policy, like all SFC policies, must be approved by the Select Board.
