Cheryl,

Thanks for your inquiry. We will discuss under "Correspondence" at our next Building Committee meeting on April 28. Please feel free to join us.

The short answer is yes, the committee has been approached by members of the Lyons family on this matter. The property in question is a lot located at 700 Mass Ave. The Town Planner has investigated this parcel and concluded it would not be viable for a public safety building. Please see the attached Planner's memorandum dated Jan 28, 2021. The planner notes a number of difficulties with this proposed site. We reviewed and discussed the memo at our meeting on Feb 17, 2021.

The committee then further investigated issues related to wetlands and the overlying protective zones for the Enclave wells which highly constrain potential uses for the property. We reviewed and discussed this with maps at our March 24 meeting. At that meeting, a member of the public in attendance strongly recommended that the Building Committee not spend any more time researching the 700 Mass Ave property.

The committee concurs with the planner that the property is not suitable for a public safety building.
