## Cemetery Restoration / Final Application for CPA Funding FY27

### 1. Brief Project Summary:

This project is the continuation of a multiyear effort to “catch up” on the repair, cleaning, restoration, and resetting of headstones, monuments, and other stonework at our cemeteries.

### 2. Narrative:

These items must be cared for. Age and other factors have brought this far beyond normal perpetual care.

### 3. Maps:

The cemeteries are located at 450 Hill Road and 420 Burroughs Road.
